DEFENSE AND SECURITY IN INTERNATIONAL RELATIONS

Objective

This course examines the nexus between international security, domestic security, and security and defense policies. The emphasis is on the problems of formulating and implementing security and defense policies. The course also explores contemporary developments related to terrorism and organized crime and their impacts on domestic and international security.

Syllabus

The course is structured in two parts: the first address the main concepts about international and subnational conflicts, while the second part aims to discuss with participants some of the most prominent contemporary challenges related to public security and defense.

The theme of Human Rights is present across the classes and as a specific topic of study, mainly when dealing with the problem of migration and displacement of populations in conflict areas. Other content covered is the threat posed by terrorism, organized crime and cybersecurity, proliferation of weapons of mass destruction, security in the post-Cold War era, and asymmetric wars. In view of changes in the international security scenario, the course addresses the elements of national power that are available to defense policy makers and the strategic outcomes achieved at the national and international level.

Evaluation Method

The evaluation of the subject will be carried out through:

The delivery of a policy brief of a maximum of 6 pages about one of the study cases presented during the first day of class. The policy brief must contain:









- a) Executive summary: summarizes the problem presented, most relevant data and the solution proposed by the student 1p.;
- b) Problem Presentation: describes the problem presented, the main actors involved and what challenge the policy brief aims to solve in solving the problem 2p.;
- c) Presentation of alternative solutions: indicates the possible alternative solutions for the challenge identified by the student, substantiating it based on bibliographic references 2p.
- d) Final Considerations: presents the final considerations of the policy brief, reinforcing its central argument and the importance of solving the identified challenge 1p; and
- e) Bibliographic References: indicate the bibliographic references used to prepare the policy brief.

The preliminary version of the policy brief is the delivery of what the student has produced regarding the following Topics: Presentation of the Problem and Presentation of alternative solutions. The focus of this stage is to help students guiding the final version of their Policy Brief.

The preliminary version of the policy brief will be presented by students in the second part of classes in September. In each class, a Case Study will be discussed.

Attachments will not be counted in the number of pages of the work.

Evaluation Criteria

Preliminary Version of the Policy Brief: 40% of the grade

Final version of the Policy Brief: 60% of the grade

In addition to these criteria, students must present an **attendance equal to or higher than 70% in the subject**, as indicated in article 84 of the USP General Regulations.
