INTERNATIONAL COURTS AND THE GUARANTEE OF SOCIAL RIGHTS

OPENING OF THE REGISTRATIONS AND CALL FOR PAPERS (RESOLUÇÃO NETI/USP No. 06/2021)

The CENTRE FOR THE STUDY OF INTERNATIONAL COURTS (*NÚCLEO DE ESTUDOS EM TRIBUNAIS INTERNACIONAIS*) OF THE FACULTY OF LAW OF THE UNIVERSITY OF SÃO PAULO makes public the eleventh edition of the BRAZILIAN SYMPOSIUM ON INTERNATIONAL COURTS AND TRIBUNALS, to be held virtually between 5 and 6 November 2021, inviting all professors, researchers, graduate students and professionals of Law, Social Sciences, International Relations and related areas to register and participate in the selection process of papers to be presented in the event and published in a resulting edited volume, under the terms of this document.

1. Expectations and criteria for the classification of the submitted papers: To be selected, the submitted paper must engage with the Symposium's theme, being a critical or doctrinal piece that brings a new contribution or points out new challenges to the implementation of decisions issued by international courts. Descriptive papers will not be accepted. Also, the paper must address some topic related to the activity of International Courts concerning Social Rights. Finally, papers should preferably be written in English or Spanish.

2. Deadlines: Registration for participation as a listener may be made from the publication of this document until 4 November 2021, and **papers must be submitted from 28 June to 14 August 2021**. There will be no extension of any of the informed deadlines.

3. Who may submit papers: Graduate students (master's and PhD students) and above (postdocs, assistant professors, full professors, etc.) in Law, Social Sciences, International Relations, or any related area. Undergraduate students and graduates may submit papers to the selection process accompanied by a co-author that is at least enrolled in a master's program.

3.1 No paper may have more than two authors, and both must have made the respective registrations.

3.2 The registration in the event entitles the submission of one paper as an individual author or co-author.

4. Submission procedure:

4.1 All paper submissions must be preceded by regular **registration** in the event, which can be done free of charge at the following link: <u>https://bit.ly/3A7itRt</u>

4.2. After completing the registration, the researcher must fully complete the **online Form for Paper Submission**, available at: <u>https://bit.ly/3dpp3ce</u>

4.3 Co-authored papers should only be submitted by one of the authors, with an appropriate indication of the co-author, if any. However, both authors must comply with the procedure provided for in item 4.1.

4.4. Papers must be submitted before 23:59 (GMT-3) 14 August 2021.

4.5. The list of approved papers will be published on 20 September 2021 at NETI-USP's website (<u>https://sites.usp.br/netiusp</u>) and social networks.

5. Criteria for approval of submitted papers:

5.1. Papers are subject to approval by at least two members of the Scientific Council of the Symposium, which will review the papers following a double-blind peer review process;

5.2 The referees shall verify compliance with the admissibility criteria described in this document, as well as: 5.2.1 Whether the paper actually contributes to the study of International Law and International Courts and Tribunals;

5.2.2 The quality of the bibliographical references;

5.2.3 The critical, reflective or innovative content of the paper according to item 1 of this document;

5.2.4. If a paper receives one approval and one rejection recommendation, it will be submitted to a third evaluation, determining the final recommendation on its acceptance or rejection.

5.3. Papers may be written in English, Spanish, or Portuguese. The publication will give precedence to papers written in English or Spanish.

5.4. The schedule of presentations during the conference will be communicated in due time to the participants. It will happen after the announcement of the approved papers.

6. Technical rules for submission:

6.1. The submitted paper should be developed between 10 to 15 pages and should contain Title; Abstract (up to 150 words); Keywords (between 3 and 5); Introduction; Content development in numbered topics; Conclusion; References.

6.2. The submitted paper may not contain any direct or indirect identification of authorship under penalty of summary elimination.

6.3. Formatting: The paper should be sent in a .doc or .docx file, and the citations should be made in authordate format with the inclusion of a list of references at the end of the paper following ABNT *or* OSCOLA standard.

7. Scientific and Evaluation Board. The Scientific and Evaluation Board will be composed of Professors and PhD researchers and may have its composition changed after the publication of this announcement.

8. Presentations:

8.1. The presentation can be in any language of the Symposium. It not necessarily needs to be the same in which the paper was written.

8.2. The language of the presentation must be chosen when filling out the form for paper submissions.

9. General provisions

9.1 In case of the paper being rejected, the registration for participation as a listener will be maintained.

9.2 All cases not mentioned in this document will be dealt with by the Organization and the Scientific Director of the Symposium. Any questions should be sent exclusively to the e-mail address simposio.netiusp@gmail.com.
